## **Use of Exquisite Certification Mark and Accreditation Symbols for ISO 9001:2015 & ISO 27001:2022**

### **1. Introduction**

- 1.1 Exquisite Certification and Audit Limited (Exquisite) is accredited by the International Accreditation Service (IAS) and may use the IAS accreditation symbols for our accreditation and claim our accreditation status are satisfied.
- 1.2 A company certified by Exquisite accredited by IAS (“certified clients”) also may use the IAS accreditation symbols.
- 1.3 Certified clients shall use the Exquisite certification mark and IAS accreditation symbols in accordance with this Policy and national and in some cases international criteria.
- 1.4 The use of Exquisite certification mark and IAS accreditation symbols by certified clients is voluntary.

### **2. IAS Accreditation Symbols**

- 2.1 Accreditation programmes are provided under IAS. Each accreditation programme has its own accreditation symbol.
- 2.2 Design of the accreditation symbols for management systems “MS” shown in Figure 1.
- 2.3 Certified clients shall use the accreditation symbols as integral entities and shall not use the IAS logo separately.
- 2.4 The formats of the IAS accreditation symbol, including its appearance, aspect ratio, colour, shade, font style, relative sizes and positions of its components and other features shall be as specified. The accreditation symbols shall be printed against a white or light colour background. It should be noted that the colour specifications of the symbols shown in Figure 1 are based on a white colour background and when printing against a background of any other colour, precaution shall be taken to ensure that the colours of the symbols are not affected. The accreditation symbols may be enlarged or reduced in size.

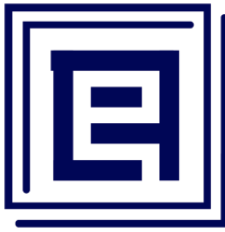

- 2.5 The minimum height of the symbols shall be 15 mm. A smaller size is acceptable if the symbol is to be displayed on an item having a small size, e.g., name cards. Irrespective of its size, the features of the accreditation symbol, the identification code and the registration number shall be clearly discernible.
- 2.6 In addition to the colour specified in Figure 1, the accreditation symbols may be displayed in a single colour, preferably of white, black, red or blue. On printed materials, displaying the symbol in the predominant colour is also acceptable. The colour of the symbols shall be chosen such that they are easily visible against the background. An example of a single colour accreditation symbol is shown in Figure

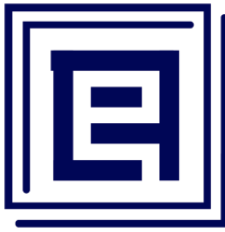

- 2.7 Where the accreditation symbols are to be displayed on materials printed using full colour, the accreditation symbols shall normally be printed in the colours as specified in Appendix 1. In cases where it is difficult to distinguish a full colour accreditation symbol from its background, a single colour accreditation symbol shall be chosen to ensure that it is easily visible.
- 2.8 When used on paper, the IAS symbols may be embossed or stamped, provided that no other modifications are made.
- 2.9 Apart from those allowed above, certified clients are not allowed to make any other modifications to the accreditation symbols.

### **3. General conditions on the use of Exquisite certification mark and IAS accreditation symbols**

- 3.1 A certified client may use the relevant IAS accreditation symbol in conjunction with Exquisite certification mark. This use is limited to its stationery, literature and advertisements and the conditions governing the use of the certification mark.
- 3.2 Certified clients shall not use Exquisite certification mark and the IAS accreditation symbol in such a manner as to bring Exquisite or IAS into disrepute and lose public trust and shall not make any statement relevant to Exquisite certification or IAS accreditation which Exquisite or IAS Executive may reasonably consider to be misleading.
- 3.3 There shall be no ambiguity, in the certification mark or accompanying text, as to what has been certified. Certified clients shall be monitored and audited their use of Exquisite certification mark and the IAS accreditation symbol to ensure the conditions governing the use of the certification mark and the accreditation symbol are complied.
- 3.4 The IAS accreditation symbol may be used by a certified client on any stationery, documents and/or publicity materials if they are related to the organisation's certification scope.
- 3.5 A certified client shall not use the IAS accreditation symbol in isolation from Exquisite certification mark.
- 3.6 Certified clients shall not use Exquisite certification mark and the IAS accreditation symbol on its products or packaging of the products or associated documentation or certificates or in any way that may be interpreted as denoting product conformity.

3.7 When a certified client uses an IAS accreditation symbol, the organisation shall:

- (a) include its own name or logo;
- (b) include Exquisite certification mark not disproportionately represented with reference to the accreditation symbol, and positioned in a manner that ensures the relationship between the accreditation symbol and the certification mark is obvious;
- (c) The certification number assigned to the organization under IAS shall be placed immediately underneath the IAS accreditation symbol and Exquisite certification mark as illustrated in Figure 3 – Figure 18.

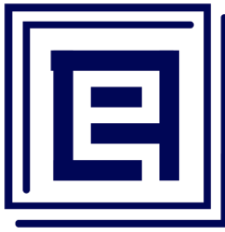

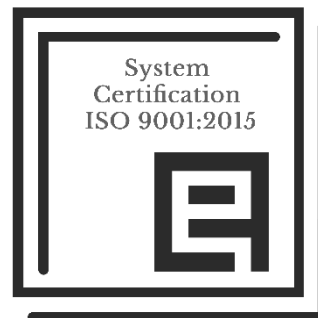

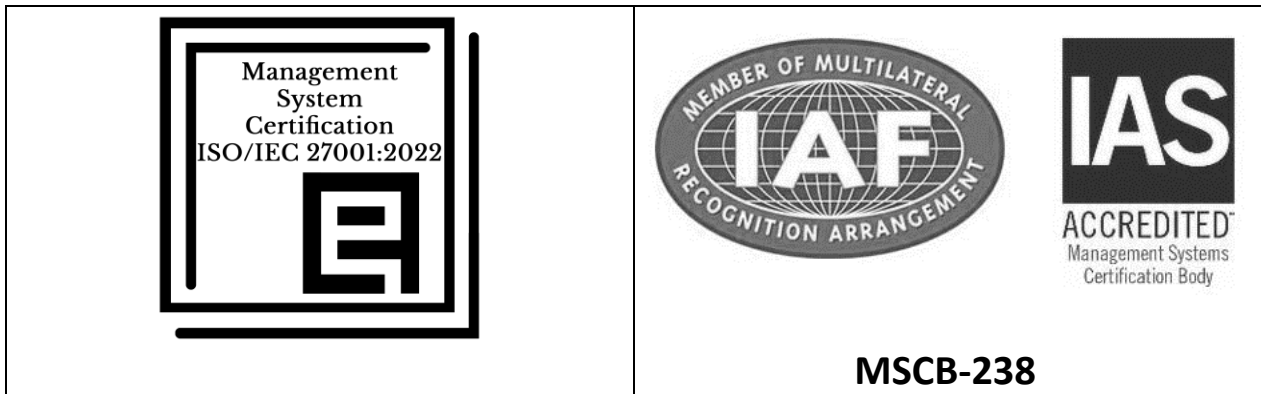

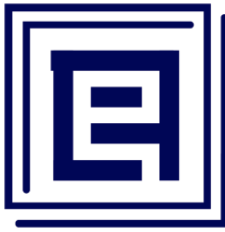

- 3.8 Electronic reproduction of Exquisite certification mark and the IAS accreditation symbols in electronic formats are permitted provided that the requirements of this Policy are met. When processing or converting the computer files of the certification mark and the accreditation symbol, degradation and distortion of the mark and symbols are not allowed.
- 3.9 Except as allowed in clause 3.2 to 3.8, a certified organization is not allowed to use any IAS accreditation symbol or claim IAS accreditation.
- 3.10 An organisation with its certification suspended or terminated by Exquisite shall forthwith stop using the relevant IAS accreditation symbol and Exquisite certification mark.

## **4. Misuse of Exquisite certification mark and IAS accreditation symbols**

- 4.1 IAS Executive will take all necessary actions against any organisations or individuals who misuse any IAS accreditation symbols and logos or incorrectly claim any accreditation status under IAS. Those actions may include suspension or termination of accreditation and legal sanction.
- 4.2 Exquisite will also take action to deal with incorrect references to certification status or misleading use of certification documents, marks or audit reports. Such action could include requests for correction and corrective action, suspension, withdrawal of certification, publication of transgression and, if necessary, legal action.
- 4.3 Exquisite certification mark and the IAS accreditation symbol with reference to its management system certification shall not be misused to imply Exquisite has certified a product/service or process, or in any other misleading manner.
- 4.4 Exquisite certification mark and the IAS accreditation symbol shall not be used to imply that the certification applies to activities and sites that are outside the scope of certification.
- 4.5 The IAS accreditation symbol for Exquisite shall not be used by a certified client without Exquisite certification mark.

## 5. Use of certification statement on product, product packaging or in accompanying information and in communication media

The table provides some guidance on the use of certification statement:

\*1. This could be a tangible product itself. Type labels or identification plates are considered as part of the product. In the case of testing / analyzing activities, the product could be a test / analysis report or certificate of conformity or certificate of training or achievement.

\*2. Product package such as individual package, container and larger boxes used for transportation of products. This could be over-packaging made of cardboard that can be reasonably considered as not reaching end users.

\*3. A certification statement in words alone does not constitute a mark. Any such wording should be true and not misleading. The certified client should clearly identify their name, type of management system and applicable standards and name of the certification body (Exquisite).

An example of statement: "This product is manufactured by XXX Company under ISO 9001:2015 quality management system / ISO/IEC 27001:2022 Information Security management system certified as being in conformity by Exquisite Certification and Audit Limited."
